3 16-05-2018 No case of initiation of contempt proceeding is made out in

view of the nature of order dated 04.05.2017 passed in C.W.J.C.

No.4028 of 2017.

The Court had merely observed in order that if the

vacancies advertised remain unfilled, candidates can be declared



successful, recommended appointment strictly on the basis of merit, list till the life of the penal survived.

There was no direction in the said order dated 04.05.2017 to make recommendation for appointment if the vacancies remained unfilled. No case of violation of this Court's order is made out. This application is, accordingly, dismissed.
