Petitioners apprehend their arrest in

**Kundwachainpur P.S. Case No.73 of 2018** instituted for the  
offence under Section(s) 342, 323, 324, 307, 354-A, 354-B, 379,  
447, 427, 504 & 506/34 Indian Penal Code.

In the written report, it is alleged that petitioner  
No.1, Rozid Ansari, abused the informant and told that he will  
establish illicit relation with her and torn her clothes. He tried to  
make illicit relation and thereafter assaulted her by means of  
*Dabila*. There is no allegation of any overt act against other



petitioners.

Injury report of the informant is enclosed as Annexure-2, which shows that the informant has sustained simple injury.

It is submitted that during investigation allegation for the offence under Sections 307, 379 and 354A Indian Penal Code was not found correct and charge-sheet has been submitted for the offence under Sections 341, 323, 324, 354(B), 447, 504 and 506/34 Indian Penal Code.

In the facts and circumstances of the case, prayer of the petitioners for grant of anticipatory bail is allowed. In the event of surrender/arrest of the petitioners, named above, within six weeks from today in connection with **Kundwachainpur P.S. Case No.73 of 2018**, they shall be released on anticipatory bail on furnishing bail bond of Rs.10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of the **Sub-Divisional Judicial Magistrate, Sikrahana at Dhaka, East Champaran**, subject to the conditions as laid down under Section 438(2) Cr. P. C. with further conditions: (1) bailors should be local having sufficient immovable property within the jurisdiction of the court concerned, (2) petitioners shall cooperate in the trial and shall be present on each and every date fixed by the court and their



absence on two consecutive dates without proper and reasonable reason will be liable to cancel their bail bonds and (3) if petitioners tamper with the evidence or the witnesses of the case, in that case, prosecution will be at liberty to move for cancellation of bail of the petitioners.
