Heard learned counsel for the petitioners and

learned Additional Public Prosecutor for the State.

The petitioners are apprehending their arrest in  
a case registered for the offences punishable under Sections  
341/323/307/498A/34 of the Indian Penal Code and Sections 3/4  
of the Dowry Prohibition Act.

This is a case under Section 498A and other  
ancillary sections of the Indian Penal Code as well as Dowry  
Prohibition Act. Notice was issued to opposite party No. 2, the  
informant of this case and wife of petitioner No. 1, but no one



appears.

Considering the general and omnibus nature of allegation and the chances of future restoration of relationship, let the petitioners, above named, in the event of their arrest or surrender before the Court below within a period of thirty days from the date of receipt of the order, be released on bail on furnishing bail bonds of Rs.20,000/- (Twenty Thousand) each with two sureties of the like amount each to the satisfaction of the learned Court-below where the case is pending in connection with Brahampur Police Station Case No. 91 of 2017, subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure as well as condition that the petitioners shall fully cooperate with the investigation/trial of the case, failing which the court below shall be at liberty to cancel the bail bond of the petitioners.
