L.P.A. No.1347 of 2014 dated 08.07.2015, the order dated 05.12.2017

relief and the claim of the petitioner for consequential relief will be

taken by the respondents after verification of the certificate issued by

verification of the certificate must be completed within a period of 60 days from the date of receipt/production of a copy of this order and based on resolution of verification, the petitioner will be considered for grant of continuity in service and for grant of other benefits.
