Heard learned counsel for the parties.

This is an appeal under Section 14(A)(2) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 against the refusal of prayer for anticipatory bail vide order dated 24.03.2018 passed by the learned Special Judge (S.C./S.T. Act)-cum-Additional Sessions Judge-I, Sitamarhi, in A.B.P. No.472 of 2018, arising out of Bela Police Station Case No.33 of 2018, registered under Sections 341/323/379/504/506 of the Indian Penal Code and Sections 3(i)(x) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989.

Appellant No.1 had lodged Bela P.S. Case No.221 of 2017 against the father of the informant of the present case and others.



Submission is that just to pressurize the present mala fide prosecution has been lodged with false allegation that appellants and others allegedly abused the informant by taking caste name and committed assault etc.

Considering the background of the allegation, let the appellants, above named, in the event of their arrest or surrender before the Court below within a period of thirty days from the date of receipt of the order, be released on bail on furnishing bail bonds of Rs.20,000/- (Twenty Thousand) each with two sureties of the like amount each to the satisfaction of the learned Court-below where the case is pending in connection with the aforesaid case, subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure as well as condition that the appellants shall fully cooperate with the investigation/trial of the case, failing which the court below shall be at liberty to cancel the bail bond of the appellants.

Accordingly, the impugned order is set aside and the appeal is allowed.
