ORAL ORDER

2 18-08-2018 The petitioner claims that he was a teacher in Shree Mahendra Das Inter College, Mathia, Nechua Jalalpur, District- Gopalganj, which receives aid from the State of Bihar. He is seeking an order from this Court restraining the State respondents from releasing funds to the Secretary, Managing Committee of the said Inter College. It is his grievance that the



Managing Committee is misusing the funds, which is being released by the State Government for payment to teaching and non-teaching employees of the College.

The petitioner has alternative remedy before Bihar Anudanit Sikshan Sansthan Pradhikar, constituted under Anudanit Shikshan Sansthan Pradhikar Niyamawali, 2015, which he can very well pursue.

This application is disposed of with observation that if he approached the authority by filing an application, his application shall be decided in accordance with law.
