In view of the law laid down by the Supreme Court in



the case of **Bholanath Mukherjee & Others Vs. Ramakrishna Mission Vivekananda Centenary College & Others- (2011) 5 Supreme Court Cases 464** and by the Delhi High in the case of **Forum of SC and ST Legislators and Parliamentarians Vs. Oil and Natural Gas Corporation Ltd. & Another (WP (C) No. 1698 of 2017)** decided on **27.02.2017**, a Public Interest Litigation with regard to the recruitment and service matter is not maintainable. Individual aggrieved may challenge the advertisement in accordance with law.

With the aforesaid, the writ petition stands dismissed.
