He submits that claim of the petitioners is to be examined in light of Annexures 6 and 7 to the writ petition which are letter dated 4.10.2012 issued by the Joint Secretary in the Department of Education and letter dated 22.01.2015 bearing memo no. 48 issued by the Special Director, Secondary Education.
