2 05-09-2018 Heard learned counsel for the petitioner and learned
counsel for the respondents.

The present application has been filed for modification
of order dated 06.12.2017 passed in C.W.J.C. No. 20373 of 2014
by which the writ petition was disposed of with liberty to the
petitioner to prefer an appeal before the District Appellate
Authority, Muzaffarpur, within a period of thirty days from the
date of order i.e., 06.12.2017.

Learned counsel for the petitioner submits that due to
