And for pending disposal of the writ application may stay the operation of the office order contained in memo no. 1624-2 dated 27-06-2018 (Annex-10) passed and issued by the respondent no. 5”.

On behalf of the petitioner, it has been submitted that the case of the petitioner is squarely covered by the order dated 30-11-2017 passed in CWJC No. 17424 of 2017.
