1. The petitioners have filed this petition seeking a direction for consideration of their claim for scale promotion on the ground that they have already completed 10 years of service and as per circular dated 14.11.2014 of the Government in Department of Panchayat and Rural Development, they are entitled to higher pay scale. It is further submitted that earlier those Assistant Teachers, who were completed 10 years of service were granted scale promotion vide order dated 23rd of August, 2016.
2. The petitioner's claim would be examined by the Chief Executive Officer, Janpad Panchayat, Antagarh, District South Bastar after due consideration of their entitlement under the circular of the Government and all other eligibility part with regard to claim of higher pay scale as early as possible preferably within a period of four months from the date of receipt of copy of this order.
3. The petition is accordingly disposed off.
