4. The prayer appears to be fair and reasonable and is accordingly allowed.

Be that as it may, the petitioners would be at liberty to make representation before the respondent Bank and, in that event, the respondent – Bank shall consider and decide the petitioners' representation on its own merits within a period of one month from the date of receipt of representation and pass a reasoned order after giving opportunity of hearing to the petitioners.
6. With the aforesaid observations, the writ petition stands finally disposed of. No order as to cost(s).
