- 1. Learned counsel for the petitioner submits that this petition, at this stage, may be disposed off with the direction to the respondents to decide the issue of confirmation of the petitioner. It is submitted that though the

petitioner was appointed way back in the year 2013 against the vacant post and his probation period has not been extended after initial one year of probation, the issue of confirmation has not been decided.
