- (2) The petitioner is working as Assistant Lineman and posted at Chhattisgarh State Power Distribution Company Limited, Keshkal.
- (3) Counsel for the petitioner would submit that the instant writ petition may be disposed of by giving direction to respondents No.2 & 3 that they shall consider and decide the pending representation of the petitioner dated 17.06.2017 (Annexure P/3) within stipulated time.
