petitioners at this juncture, let the petitioners make detailed representations to the respondent within a period of 15 days from today and on such representations being made, let the respondent consider the claim of the petitioners on its merits and pass a suitable order in accordance with the rules governing the field. Let this decision be taken within a further period of 90 days from the date of receipt of representation.

4. The writ petition accordingly stands disposed of.
