2. The petitioner challenges the circular dated 28.10.2005 issued by the Commissioner for Co-operation on the ground that the same is not in conformity with Section 69 (A) of Maharashtra Co-operative Societies Act, 1960.

3. The learned A.G.P. submits that the Section 69(A) of Maharashtra Co-operative Societies Act, 1960 stands deleted with effect from 13.08.2013.
