O R D E R

1. Mr. Pandit Rohidas Sirsath, Executive Engineer, Nandur Madhmeshwar Irrigation Division, Vaijapur, Sandipan Suryakant Sanap, Sub Divisional Officer, Vaijapur and Mr. Jagannath S. Dange, Sectional Engineer, are present before the panel. Mr. V.R. Sonwalkar, Mr. P.G. Rodge, Mr. S.S. Thombre and Mr. V.M. Lomte learned counsel appearing for the appellant-acquiring body, Mr. A.M. Hajare, Mr. A.S. Shejwal and Mr. M.R. Malpani, learned counsel for respondents-original claimants and Mr. A.M. Phule, learned A.G.P. for the respondent-State authorities are also present.

2. Mr. Pandit Rohidas Sirsath, Executive Engineer, Nandur Madhmeshwar Irrigation Division, Vaijapur, has placed on record a

communication dated 10.07.2018 issued by him to the Government Pleaders' office, High Court, Bench at Aurangabad. The said communication is taken on record and marked "X" for identification.

3. Mr. V.R. Sonwalkar, Mr. P.G. Rodge, Mr. S.S. Thombre and Mr. V.M. Lomte, learned counsel appearing for the appellant-acquiring body, on instructions from the aforesaid officers, who are present before the panel submit that the rate awarded by the impugned judgment and award passed by the reference court is less than four times of the rate awarded by the S.L.A.O. In view of above, Mr. V.R. Sonwalkar, Mr. P.G. Rodge, Mr. S.S. Thombre and Mr. V.M. Lomte, learned counsel appearing for appellant-acquiring body, on instructions from the officers, who are present before the panel and in tune with the Government Resolution dated 03.11.2016 and the subsequent corrigendum dated 23.02.2017 seek leave to withdraw these first appeals.

4. Since the acquiring body has taken decision to settle the dispute finally, which squarely falls in the category of Government Resolution dated 03.11.2016 and the subsequent corrigendum dated 23.02.2017, leave granted. All first appeals/rejected cases are disposed of as withdrawn. Court fees be refunded as per Rules. Pending civil applications, if any, are also disposed of. Statutory

benefits be extended in accordance with law.

5. In terms of the letter dated 10.7.2018, in some of the matters, the appellant acquiring body has deposited the amount as per the award passed by the reference court and in case if the amount as per the award passed by the reference court is not deposited before this Court or in the executing court, it is agreed that the same would be deposited within six months from today. The amount if paid in excess be refunded to the acquiring body.
