3. Learned counsel are ad idem that :

I. On page 19, paragraph number 16 (9th line), the sentence "*The petitioners filed application U/s 17 of the SARFAESI Act*" is required to be replaced by "*The Respondents filed application U/s 17 of the SARFAESI Act*".

II. On page 20, paragraph number 16 (4th line), the word "*the Petitioners*" is required to be replaced by "*the Respondents*".

III. On page 20, paragraph number 17 (2nd line), the word "*the Petitioners*" is required to be replaced by "*the Respondents*".
