ORDER

1. The learned advocate Mr. B.R.Surwase for the appellant, on instructions from Mr. Buwasaheb Dnyanoba Bade, Sub Divisional Officer, IPS, Sub Division No.6, Vaijapur, submits that except the dispute regarding interest awarded by the Trial Court, the fact situation is squarely covered by the Government Resolution dated 03.11.2016 and the Corrigendum dated 23.02.2017 and

13.08.2018 and therefore the appellant seeks to withdraw the appeals since the question of interest is covered by the Full Bench in the case of ***State of Maharashtra Vs. Kailash Shiva Rangari ; 2016 (4) ALL MR 513 (F.B.)***.

2. The appeals are disposed of as withdrawn.
3. The praecipe filed by the learned advocate Mr. Surwase is taken on record and marked Exh-X.
4. The claimant shall be entitled to receive the amount deposited in this Court, if any, together with interest accrued thereon.
5. Court fee be refunded as per rules.
