ORDER

1) All these appeals are filed by Executive Engineer Majalgaon Canal Division No. 10, Parbhani. Shri B.R.Shingare, Executive Engineer is present before the Lok Adalat. The acquiring body is represented by Advocates Shri Y.S.Karad h/f. Shri S.S.Thombare, S.G.Bhalerao, S.C.Arora, R.C.Patil and Assistant Government Pleaders Shri A.M. Phule, Shri B.V. Virdhe and Shri S.S.Dande are representing the State.

2) Advocate Shri S.G.Bhalerao and Advocate Shri S.C.Arora are present before the Lok Adalat. Advocate Shri S.G. Bhalerao submitted that he is representing for Shri R.C.Patil.

3) It is submitted that in view of the policy adopted by the Government vide Government Resolution dated 03/11/2016 read with Corrigendum dated 23/02/2017, the appellants i.e. Acquiring Body now decided not to prosecute these appeals further. It is submitted that in all these matters the Acquiring Body has already deposited amount of

compensation in this Court.

4) In view of the submission so made, all the above appeals stand disposed of as withdrawn.

5) Appellants shall be entitled to withdraw the Court fee in accordance with law.
