**JUDGMENT( Per T.V. NALWADE, J] :-**

Rule. Rule made returnable forthwith. By consent heard both the sides for final disposal.

2] This proceeding is filed for quashing of FIR No. 352/2014, registered with CIDCO police station, Aurangabad for the offences punishable under Sections 324, 323, 34, 504, 506, read with Section 34 of the Indian Penal Code and under Sections 2, 3 and 4 of the Maharashtra Anti-Ragging Act, 1999.

3] During the argument, the learned counsels for the applicant and respondent no.2 submits that parties have settled the dispute. Joint compromise pursis is filed on record.

4] Learned A.PP opposed the application by submitting that there is medical certificate showing that severe beating was given and there were at least eight injuries found on the person of informant. All the three boys are present before this Court. Fortunately they completed degree course and they are now doing some course after degree. Such incidents will affect their carrier and this conduct also affects the parents of the boys who must have spent hudge amount on their education. In view of this circumstances, the application is allowed. Relief is granted in terms of prayer clause [F]. Rule made absolute in those terms.
