PER COURT:-

1. Shri R.J.Nirmal, learned counsel submits that he has instructions to appear for the respondents, i.e. original claimants in all these matters and he will file his Vakalatnama in the Registry within two weeks.

2. Delay of 393 days has occurred in filing these appeals by the acquiring body. Though

The learned counsel further submits that Cheques are already received from the acquiring body and undertakes to deposit the same within a week.
