ORDER

1. The present appeals are filed by the Executive Engineer, Lower Terna Canal Division No.2, Latur Dist. Latur, challenging the order passed by the Reference Court under Section 18 of the Land Acquisition Act.

2. Shri. I. M. Chishti, Executive Engineer present before the panel. Shri. B. R. Surwase, Advocate, is appearing for acquiring body. Shri. A. M. Phule, Shri. B. V. Virdhe and Shri. S. S. Dande learned A.G.P represent the State.

3. It is submitted that the Acquiring Body has deposited the entire amount of award alongwith interest accrued thereon before the Reference Court. It is further submitted that the Acquiring Body / State does not wish to prosecute these appeals further in view of the policy adopted by the Government vide Government Resolution dated 3rd November, 2016, read with corrigendum dated 23rd February, 2017.

4. In view of the submission so made, appeals stand dispose of since withdrawn.

5. The appellants are entitled for refund of Court fees as per

Rules.
