ORDER

1. The present appeals are filed by the Executive Engineer, Latur Minor Irrigation Division, Latur.
2. Shri. Atul Kale, Advocate, for acquiring body and Shri. I. M. Chishti, Executive Engineer, and Shri. R. K. Ashtekar, Advocate for respondents i.e. original claimants, are present before the Panel.
3. It is submitted that the Acquiring Body / State does not wish to prosecute these appeals further in view of the policy adopted by the Government vide Government Resolution dated 3rd November, 2016, read with corrigendum dated 23rd February, 2017. The acquiring body has already deposited the amount before the Reference Court. There is no dispute about the said position. The claimants are ready to accept the amount without any dispute as full and final settlement.

4. In view of the above, the First Appeals stand disposed of since withdrawn.

5. The appellants shall be entitled for refund of Court fees as per Rules.

6. Civil Applications, if any, stand disposed of.
