Heard learned Counsel appearing on behalf of the applicant.

2. By the present application, the applicant who is original claimant prays for withdrawal of the amount of interest accrued on the amount invested in fixed deposit.

3. Learned Counsel submitted that in view of the orders of this Court, the applicant was permitted to withdraw the amount by submitting bank
