1. We have heard the learned Govt. Pleader Mr. Vagyani, who has placed before us a copy of order dated 18/12/2017 passed by the Division Bench of this court (Coram :Smt. Vasanti A. Naik and Mr. Sarang V. Kotwal,JJ.) in Letters Patent Appeal No. 7 of 2017 along with connected matters, which is taken on record. The learned Govt. Pleader has also placed on record chart showing details of stages with remarks as to whether proposal in a case was forwarded or not, which is taken on record and

marked “X” for identification. There are 33 cases listed in the said chart. Out of these 33 cases, in 4 cases employees/workers were made permanent. In about 11 cases proposal was not forwarded. In the remaining 18 cases proposal was forwarded.

2. We find that the facts dealt with by the Division Bench of this court in Letters Patent Appeal No. 7 of 2017 along with connected matters decided on 18/12/2017 are similar to the fact situation in the present appeals placed before us. We find that on similar lines and adopting the same reasoning, these appeals can be disposed of.

3. We accordingly dismiss all the Letters Patent Appeals in terms of the order dated 18/12/2017 passed by the Division Bench of this Court in Letters Patent Appeal No. 7 of 2017 along with connected matters. The State Government shall undertake appropriate compliance of the order passed by the Industrial Court.

4. All the Civil Applications do not survive and are disposed of.
