3 We make it clear that if by 14th July 2018 the amount is not deposited, serious view will be taken and the matters will have to be placed before the appropriate Bench for initiating action under the Contempt of Courts Act, 1971. It is also pointed out to us that the acquiring body – Maharashtra Krishna Vally Development Corporation is also a party to the consent terms.
