1. These are the applications under Section-438 of the Code of Criminal Procedure for pre-arrest bail in C.R.No.I-393 dated 17.06.2017 registered with Manpada Police Station, Dombivali under Sections 265, 267, 420, 465, 468 r/w.34 of the Indian Penal Code.
2. The Division Bench of this Court by its Order dated 05.12.2017 has granted stay to the effect and operation of any proceeding arising out of the

afore-stated crime. In view thereof, the Investigating Agency cannot seek custody of the applicants under the guise of conducting investigation of the present crime.

3. In view of the above, the applicants are entitled to be protected by pre-arrest bail.

4. Hence, the following order.

a) In the event of arrest of applicants in C.R.No.I-393 dated 17.06.2017 registered with Manpada Police Station, Dombivali, the applicants shall be released on bail on their furnishing PR bond of Rs.25,000/- each with one or two separate solvent local sureties in the like amount.

b) The applicants shall not tamper with the evidence and/or pressurize the prosecution witnesses.

5. Applications are allowed in the aforesaid terms.
