- (iv) We direct the parties to appear before the Reference Court on 3rd August 2018 at 11.00 am to enable the Reference Court to pass consequential order regarding cancellation of bank guarantee, withdrawal/disbursal of the amounts, etc.;
- (v) Pending Civil Applications do not survive and the same are disposed of.
