1 There is consensus among the counsel appearing for the respective parties that aforesaid mentioned Criminal Appeals and Criminal Applications can be disposed of in view

of subsequent developments, after filing the aforesaid proceedings, that a Special Court is appointed under section 22 of National Investigating Agency Act, 2008. However, the learned counsel appearing for the respective applicant - accused jointly submit that the concerned court may be directed to expedite the trials, to be completed within a period of year.

In case the trial is not concluded within a period of one year, liberty to apply for further directions. Ordered accordingly.
