1. These petitions under Article 226 of the Constitution of India, challenge the common order dated 9th January, 2018 passed by the Authority for Advance Ruling (AAR). By the common impugned order dated 9th January, 2018, the thirty applications of the petitioners before us were rejected by the AAR under Section 245R(2) of the Income Tax Act, 1961 (the Act).

2. After hearing the parties for some time, it is submitted by the Advocates for the petitioner, on instructions that, the impugned order dated 9th January, 2018 of the AAR be quashed and set aside. Mr. Singh, Learned Counsel appearing on behalf of the respondent-Revenue, on instructions, states that, the applications relating to Writ Petitions No. 1544 of 2018, 1545 of 2018, 1546 of 2018, 1580 of 2018, 1581 of 2018, 1583 of 2018, 1586 of 2018 and 1590 of 2018 may be restored to the AAR for fresh disposal from the stage of Section 245R(2) of the Act. The Learned Counsel appearing for the

petitioner, on instructions, has no objection to the same. Thus, the impugned order is set aside to the extent of the above eight petitions.

3. In the above view, the writ petitions referred to hereinabove viz. Writ Petitions No. 1544 of 2018, 1545 of 2018, 1546 of 2018, 1580 of 2018, 1581 of 2018, 1583 of 2018, 1586 of 2018 and 1590 of 2018 are allowed and the applications relevant to these petitions are restored to the AAR for fresh disposal from the stage of Section 245R(2) of the Act in accordance with law.

4. In view of the above, Mr. Porus Kaka, Learned Senior Counsel appearing for the petitioner, on instructions, seeks to withdraw rest of the twenty-two petitions challenging the impugned order dated 9<sup>th</sup> January, 2018 of the AAR. However, with liberty to file applications before the Advance Ruling, if so advised, on the final disposal of the applications which have been restored to the AAR.

Therefore, the balance twenty-two petitions i.e. Writ Petition Nos. 1554 of 2018, 1555 of 2018, 1556 of 2018, 1557 of 2018, 1558 of 2018, 1559 of 2018, 1573 of 2018, 1574 of 2018, 1575 of 2018, 1576 of 2018, 1577 of 2018, 1578 of 2018, 1585 of 2018, 1587 of 2018, 1588 of 2018, 1589 of 2018, 1597 of 2018, 1610 of 2018, 1618 of 2018, 1623 of 2018, 1642 of 2018 and 1646 of 2018 are dismissed as withdrawn with the liberty sought for.

6. All petitions are disposed of in above terms. All contentions kept open.
