1. By consent of parties the following order is passed:-

- The parties to refer the disputes and differences arising out of the following proceedings to arbitration:-
 - The above Company Petition No. 511/2016 between M/s. Sachin Corporation VS Kusuma Bhandary Developers Pvt Ltd.,
 - Comm. Summary Suit No. 471 of 2016 Between M/s. Sachin Corporation & Anr., VS Kusuma Bhandary Developers Pvt Ltd., now pending in High Court, Bombay.
 - Comm. Summary Suit No. 483 of 2016 between M/s. Sachin Corporation & Anr., VS Kusuma Bhandary Construction Pvt Ltd., now pending in High Court, Bombay.
 - Comm. Suit (L) No. 630 of 2016 between Kusuma Bhandary Developers Pvt Ltd., VS Sachin Corporation & Ors., now pending in High Court, Bombay.
 - Summary Suit No. 227 of 2016 between Yashashree T. Shetty VS M/s. Kusuma Bhandary Construction Pvt Ltd., now pending in Bombay City Civil Court at Elphinstone.
- The parties agree to appoint Mr. Ramesh Kant as the sole arbitrator to decide the aforesaid disputes.

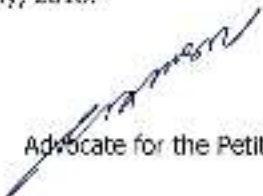

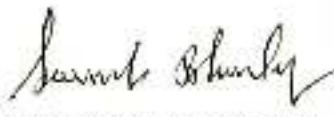
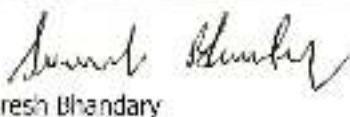

- iii. All contentions of the parties are kept open. The parties agree not to take any objection of arbitrability of the disputes.
- iv. The parties are at liberty to make interim applications before the learned Arbitrator which shall be decided on its own merit.
- v. Both parties agree to defer their criminal complaints already instituted against each until passing of the award in the aforesaid reference. However, this will not come in the way of either parties filing any new complaint / criminal proceedings, but the said complaint / proceedings shall not be prosecuted until passing of the award.
- vi. Costs of arbitration shall be initially borne equally by the parties.
- vii. The sole Arbitrator shall endeavor to complete the Arbitration by passing an award within a period of one year from today.

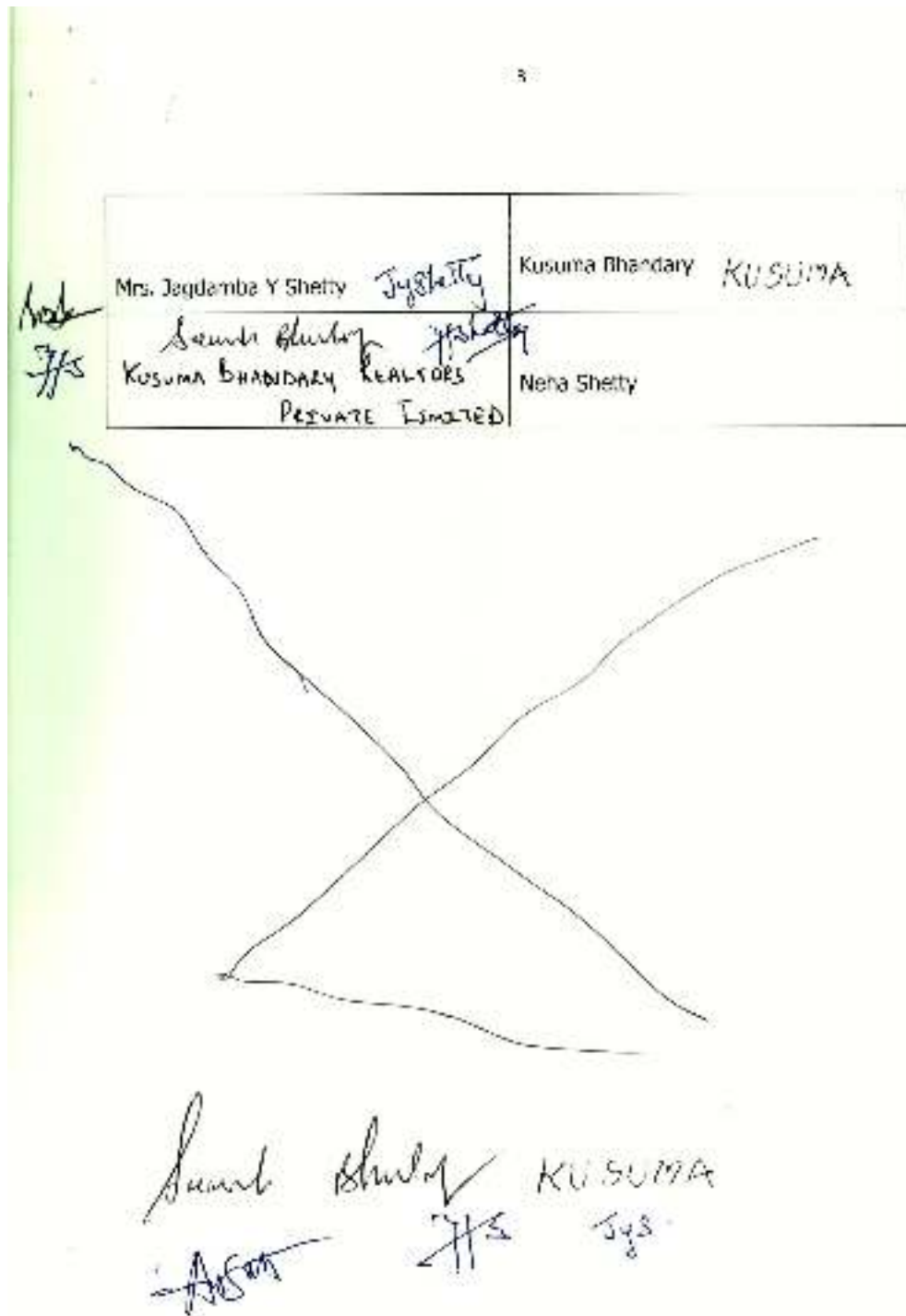

prathameshkamat@gmail.com, is appointed as sole arbitrator to decide on all disputes as stated in the consent terms including counter claim, if any. Mr.Kamat to make a disclosure in writing as required under Section 11(8) read with section 12(1) of the Arbitration & Conciliation Act 1996 within two weeks of receiving a copy of this order either from petitioners' advocate or respondents' advocate directly to the parties. Cost in the arbitral proceedings to be shared equally between the parties and the same will be subject matter of the award.

5 Petition accordingly stands disposed as withdrawn.

6 So far as Commercial Summary Suit No.471 of 2016, Commercial Suit No.403 of 2016, Commercial Suit (L) No.830 of 2018, counsel states that though these suits are not part of the assignment of this court, this court may take up the matter and permit the respective plaintiffs to withdraw the suit. These three suits are dismissed as withdrawn. Refund of court fees if any, in accordance with rules.

7 Mr.Sharma appearing for plaintiff in Commercial Suit (L)
No.830 of 2018 undertakes to remove all office objections
notwithstanding withdrawal of the suit and to have the suit numbered.

8 So far as Summary Suit No.227 of 2016 pending before
Bombay City Civil Court, Dindoshi, is concerned, Mr.Sasidharan
undertakes to withdraw the suit within 2 weeks after Neha Shetty
signs the present consent terms. Undertaking accepted.
