1. Heard learned counsel appearing for the Review Petitioners. The first submission is that the issue of jurisdiction of the DRI was raised in the Appeal and was specifically urged before this Court, but has not been considered. However, we find from paragraph 9 of our judgment that the said issue was admittedly not raised before the Appellate Tribunal at the time of hearing. Therefore, this is no ground for Review.
