Civil Application No.1529/2018

2. The appellant has filed the present appeal challenging judgment and decree dated 16.12.2014 passed by learned 3rd Joint Civil Judge Senior Division, Yavatmal in Land Reference No.168/2008 whereby the reference under Section 18 filed by respondent No.1 is partly allowed.

The appellant has filed a Pursis vide Stamp No.14849/2018 along with communication addressed to learned counsel for the appellant pointing out that the appellant has already deposited Rs.75,67,571/- before the Reference Court towards part satisfaction of the decree.
