The learned advocate for the appellant has submitted that the valuation of the acquired land as per ready reckoner was Rs.39,000/- per hectare on the date of issuance of notification under Section 4 of the Land Acquisition Act, 1894. The reference Court has granted compensation @ Rs.2,00,000/- per hectare.

Considering the facts of the case, the appellants are permitted to withdraw Rs.12,00,000/- from the amount deposited by the appellant with the Registry of this Court. The balance amount be kept in fixed deposit in a nationalized bank until further orders.

The civil applications are **disposed** accordingly.
