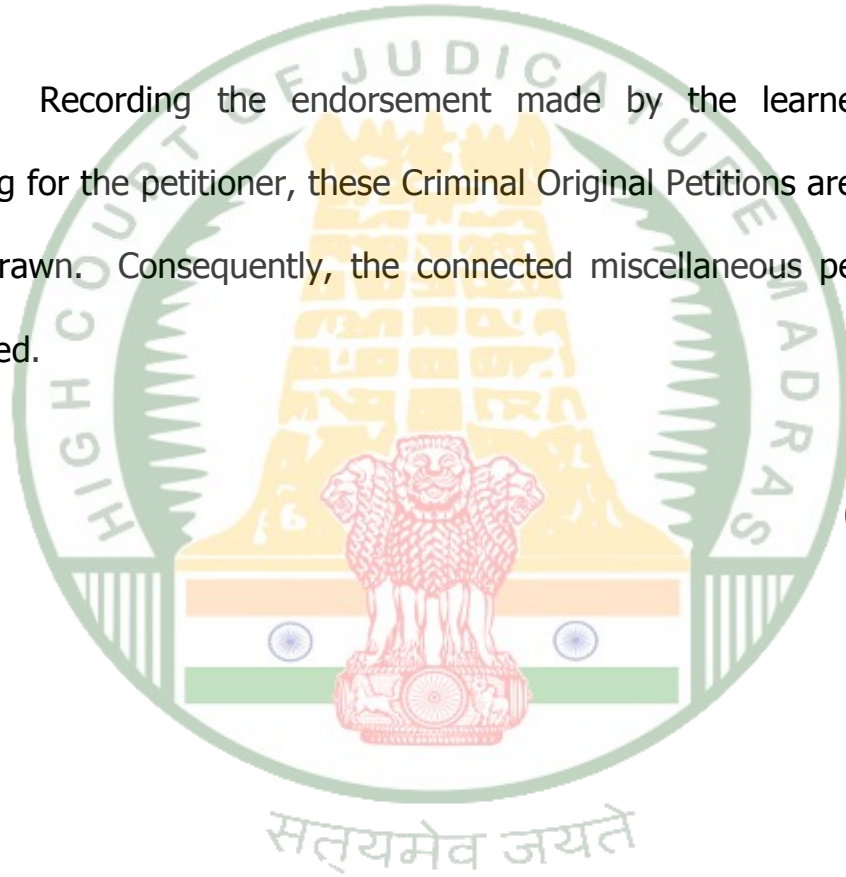
COMMON ORDER

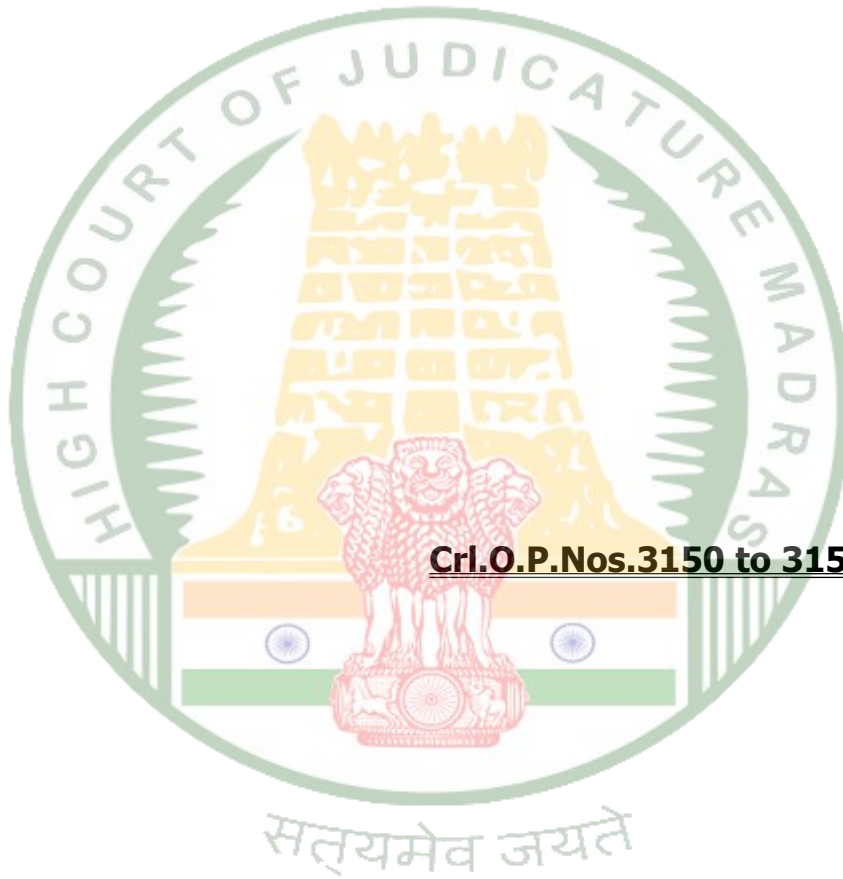
