up for final disposal at the admission stage itself.

3. The petitioner seeks for a direction to the third respondent to consider his representation dated 29.01.2018, wherein and whereby, he sought for furnishing certain documents pertaining to sale proceedings.

4. The grievance of the petitioner before this Court is that the said representation has not been considered so far. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the third respondent to consider and decide the same on merits and in accordance with law. Accordingly, this writ petition is disposed of, only by directing the third respondent to consider the representation of the petitioner dated 29.01.2018 and pass orders on the same on merits and in accordance with law, after hearing the petitioner as well as other rival claimants, if any. Such exercise shall be done by the third respondent within a period of four weeks from the date of receipt of a copy of this order. No costs.
