2.Heard Mr.P.Veeraraghavan, learned counsel appearing for the petitioner, Mr.D.Raja, learned Additional Government Pleader appearing for respondents 1 to 3 and Mr.B.Sudharasana Sundar, learned counsel appearing for the 4th respondent.

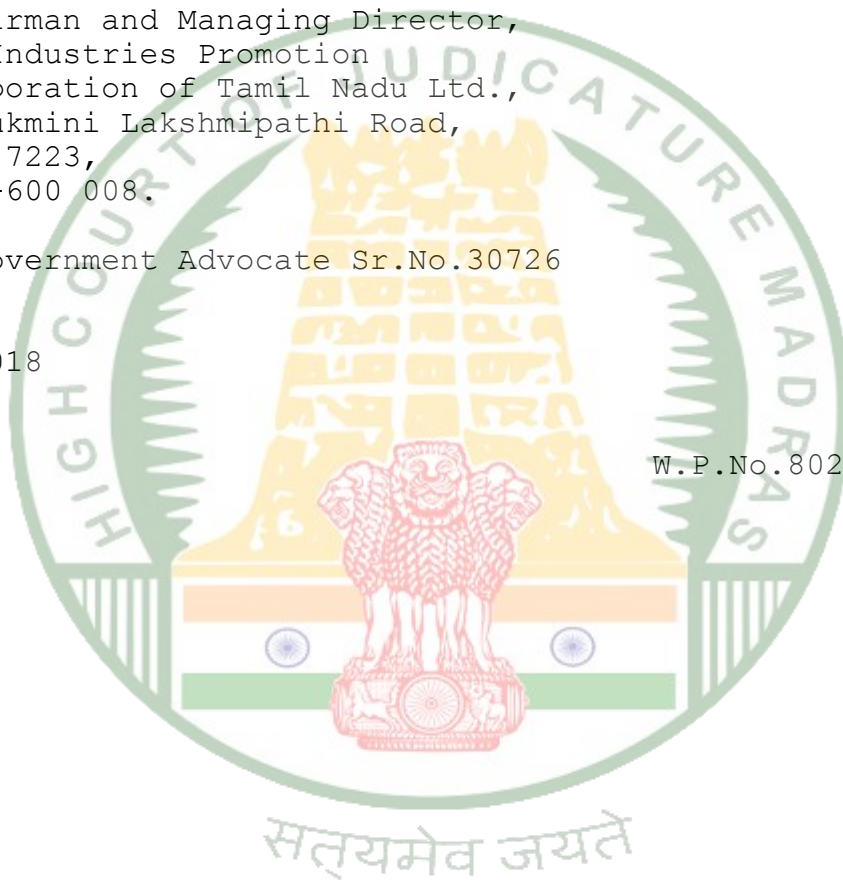
