This petition is filed by the husband of the detinue, seeking production of his wife Vidhya, aged about 25 years.

2. Today, the detinue is produced before this Court.

3. When we enquired the detinue, she has submitted that she wants to live along with her mother and this was informed to her husband, the petitioner herein.

4. The petitioner submitted that he married the victim girl, but, the detinue being a major, she is entitled to chart out the course of her life. However, it is open to the petitioner to move the appropriate forum, to work out his remedy.

5. Accordingly, the Habeas Corpus Petition is closed.

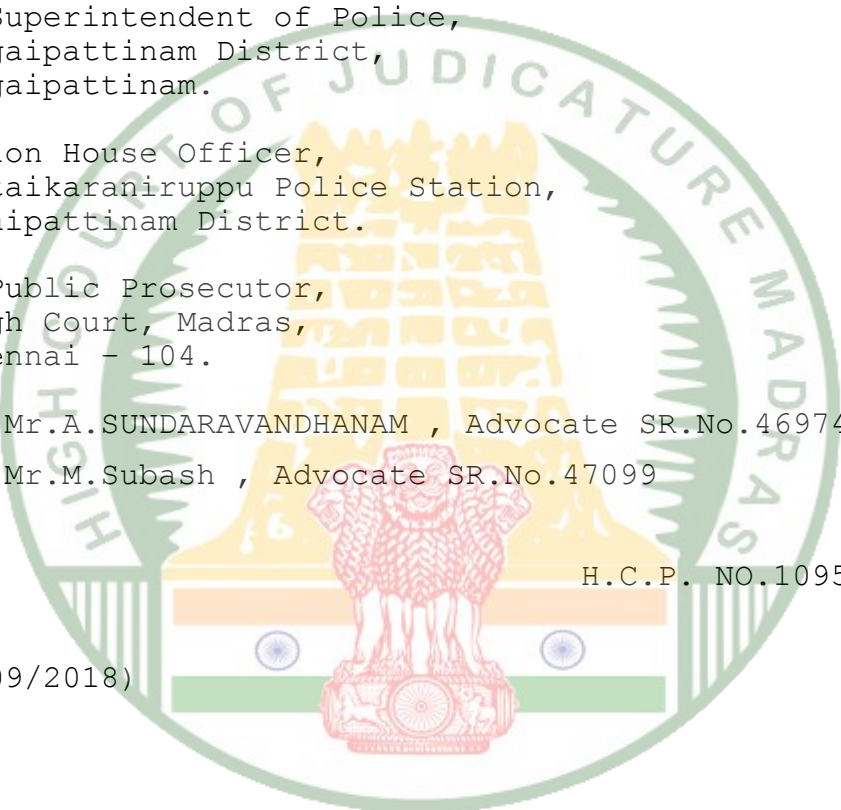
