Notice of motion returnable by two weeks.

2. The sentence of the imprisonment imposed on the petitioner shall stand suspended for a period of two weeks and the petitioner shall be released on bail on his executing a bond for a sum of

Rs.10,000/- with two sureties each for a likesum to the satisfaction of the trial Court and on a further condition that the petitioner shall report before the trial Court on the first working day of every week at 10.30 a.m., pending disposal of the revision.

3. In view of the suspension of sentence, the petitioner is exempted from surrendering before the appellate Court and Crl.M.P.No.10086 of 2018 is ordered accordingly.
