[ii]exempt the petitioner from surrendering in pursuant to the Judgment dated 07.06.2018 made in C.A.No.160 of 2010 on the file of IIIrd Additional Sessions Judge, Salem confirming the judgment dated 12.10.2010 made in C.C.No.292 of 2001 on the file of Judicial Magistrate No.4, Salem pending disposal of the above Criminal Revision. Order : This petition coming on for orders upon perusing the petition and upon hearing the arguments of M/S.G.ARUL MURUGAN Advocate for the petitioner, the court made the following order:-

Notice of motion returnable by two weeks.

2. The sentence of the imprisonment imposed on the petitioner shall stand suspended for a period of two weeks and the petitioner shall be released on bail on his executing a bond for a sum of Rs.10,000/- with two sureties each for a likesum to the satisfaction of the trial Court and on a further condition that the petitioner shall report before the trial Court on the first working day of every week at 10.30 a.m., pending disposal of the revision.

3. In view of the suspension of sentence, the petitioner is exempted from surrendering before the appellate Court and Crl.M.P.No.10088 of 2018 is ordered accordingly.
