2. Mr.C.Prakasam, learned counsel for the petitioner submitted that when the second respondent has issued notice dated 20.06.2017, calling upon the petitioner to appear for enquiry on 29.06.2017 along with all relevant documents, pursuant thereto, the petitioner appeared for enquiry and produced all relevant documents before the Enquiry Officer and having satisfied thereon, till date the respondents did not pass

any order and therefore, direction may be issued to the respondents to conclude the enquiry at the earliest and pass final order.
