Writ petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Mandamus, directing the respondents to consider the representation dated 25.07.2017 seeking to survey and sub divide and issue Patta in petitioner's favour for the land comprised in Survey No.108A/7 at Munkilthurai Pattu Village, Sangarapuram Taluk, Villupuram District measuring to an extent of 17 cents.

Mr.R.Govindasamy, learned Special Government Pleader takes notice for the respondents. By consent of the parties, the main writ petition is taken up for final disposal at the admission stage itself.

2. The petitioner seeks for a mandamus directing the respondents to consider his representation dated 25.07.2017, wherein and whereby, he sought for surveying and subdividing the land comprised in Survey No.108A/7 at Munkilthurai Pattu Village, Sangarapuram Taluk, Villupuram District measuring to an

extent of 17 cents and consequently, seeks for issuance of Patta in his favour.

3. Heard both sides.

4. The grievance of the petitioner before this Court is that the said request has not been considered by the respondents so far. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the second respondent to consider and decide the same. Thus, this writ petition is disposed of, only with a direction to the second respondent to consider the representation of the petitioner dated 25.07.2017 and pass orders on the same, on merits and in accordance with law, after hearing the petitioner as well as the rival claimants and other interested parties, if any. Such exercise shall be done by the second respondent within a period of eight weeks from the date of receipt of a copy of this order. No costs.
