Learned Additional Public Prosecutor has filed a memo informing that the alleged detainee has been arrested in connection with Crime No.4 of 2018 on the file of Ananthasagaram Police Station and produced before the Judicial First Class Magistrate, Athmakur, Nellore District on 01.02.2018 and is now confined in Central Prison, Nellore, Andhra Pradesh. In the above circumstances, it is apparent that there is no illegal detention involved.

3. Accordingly, this Habeas Corpus Petition stand closed .

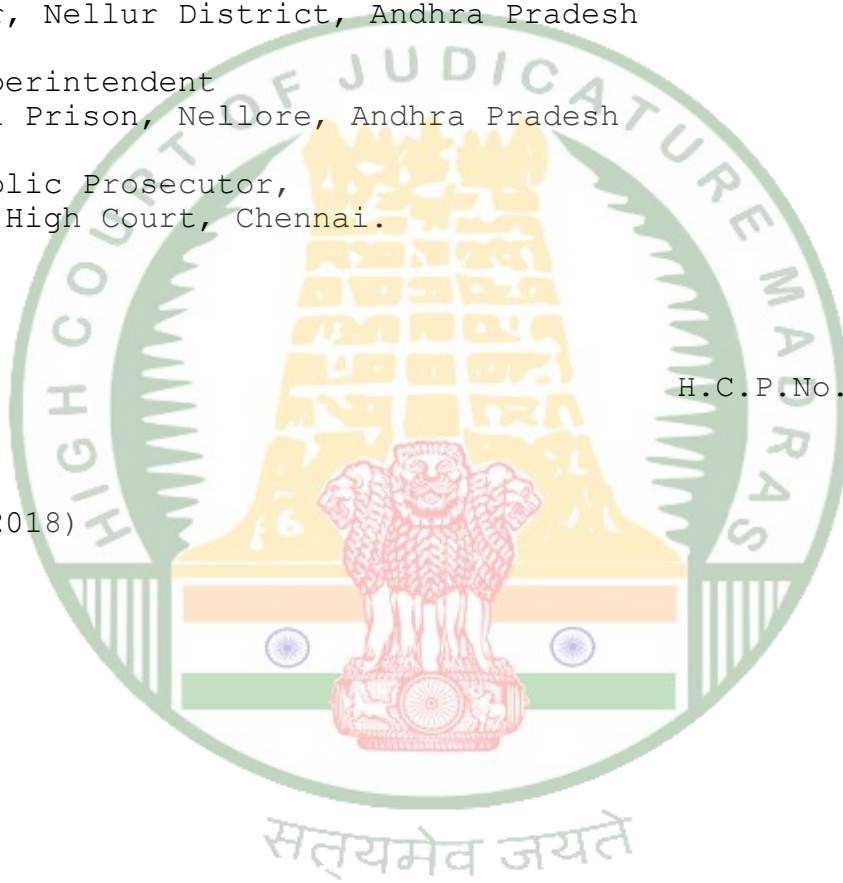
