No. 345 of 2017 on the file of the learned Judicial Magistrate Court No.1, Udumalpet.

5. Recording the same, the proceedings in C.C. No. 345 of 2017 on the file of the learned Judicial Magistrate Court No.1, Udumalpet is quashed. The Criminal Original Petition is allowed.
