Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Madamus, calling for the records from the file of 2nd respondent pertaining to the impugned order of tax enhancement made to the petitioner's property dated 14.11.2014 in notice Ref.No.7/14-15/3380 revising the tax from Rs.54,428/- to Rs.2,24,755/- and the subsequent final warrant notice issued by the 2nd respondent in vide Notice dated 02.02.2018 and to quash the same as it is arbitrary, improper and illegal and it is against the Chennai Municipal Corporation Act, 1919 and thereby to restrain the respondents 1 and 2 from taking any coercive steps against the petitioner in the name of collecting the property tax arrears from the petitioner and his property bearing Plot No.77, Sidco Industrial Estate SP, Mannurpet Village, Ambattur, Chennai - 600 058 together with a building thereon.
