The petitioner seeks for a Mandamus, directing the respondents 1 to 3 to consider his representation dated 03.01.2018, wherein and whereby, he sought for cancellation of Patta Nos.2463 and 1177, relating to Survey No.209/3 of Thorapalli Agraharam (Thippalam Village), Hosur Taluk, Krishnagiri District.

3. The grievance of the petitioner before this Court is that the said representation has not been considered so far. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the first respondent to consider and decide the same.
