2. Heard the learned counsel for the petitioner and the learned counsel for the respondent.

The learned Additional Advocate General submitted that as per the order of this Court dated 17.01.2018, on line Website I.D. number could not be furnished to the petitioner, due to technical reason and now the respondent-Corporation has decided to cancel the tender process.
