Writ petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Mandamus, directing the first respondent to consider and pass orders on the petitioner's representation, dated 2.11.2017 as per the procedure laid down under T.N.Patta Pass Book Act, 1983, for issuance of notice and hold enquiry relating to the petitioner's family property comprised in Survey No.109/2, in respect of the original etnry of Patta No.38, stands in the name of her father late.M.Krishnamurthy, and Patta No.71 stands in the name of her mother Late M.K.Sudheshna at Hebiranpuram Village, Ponneri Taluk, Tiruvallur District, within any prescribed period of time.

3. The petitioner seeks for a mandamus directing the first respondent to consider and pass orders on the petitioner's representation dated 02.11.2017, wherein and whereby she sought for issuance of Patta in her favour, in respect of the subject

matter property.

4. The grievance of the petitioner before this Court is that the said representation has not been considered so far. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the first respondent to consider and decide the same on merits and in accordance with law. Accordingly, this writ petition is disposed of, only by directing the first respondent to consider the representation of the petitioner dated 02.11.2017 and pass orders on the same on merits and in accordance with law, after hearing the petitioner as well as the rival claimants, if any. Such exercise shall be done by the first respondent within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
