Writ Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of mandamus, directing the Respondents to consider and pass orders on the Petitioner's representation dated 06.11.2017 as per the provisions of the Street Vendors (Protection of Livelihood Regulation) Act, 2014 made for granting permission/Certificate of Vending and till such time not to disturb with the running of the Petitioner's pushcart shop at 'A' Road, opposite to CMDA Lorry Parking, near Office of the Chief Administrative Officer, Market Management Committee, Koyambedu wholesale Market Complex, Chennai 600 092.

ORDER

The Petitioner has come up with the present Writ Petition seeking a direction to the Respondents to consider and pass orders on his representation dated 06.11.2017 as per the provisions of the Street Vendors (Protection of Livelihood Regulation) Act, 2014 made for granting permission/Certificate of Vending and till such time not to disturb with the running of his pushcart shop at 'A' Road, opposite to CMDA Lorry Parking, near Office of the Chief Administrative Officer, Market Management Committee, Koyambedu wholesale Market Complex, Chennai 600 092.

2. This Court has already taken a view with regard to the issue in question in **W.P.Nos.32355 of 2017 batch of cases, vide order dated 21.12.2017** and hence, the Petitioner herein cannot be in a better footing than the Petitioners, who are covered by the order cited supra.

3. In view of the above, this Court is of the view that if the Petitioner is found eligible and comes within the enumerated list and fulfills other norms that are prescribed by the Hawking/Vending Committee, his request may be

considered by the authorities. However, this will not give any right to the Petitioner to claim the Hawking/Vending Zone or any place in the area that has been allotted to SIDCO.

This Writ Petition is disposed of with the above direction and observation. No costs.
